

## **REVISED BID ADVERTISEMENT**

Sealed bids will be received by the Treasurer of West Branch (Ohio) Local School District, 14277 South Main Street, Beloit, Ohio 44609 for the following project:

### **Stadium Track Renovation Phase I**

The project consists of the following bid packages:

Bid Package #3      Track Coating System.

The project shall proceed in accordance with the Contract Documents prepared by The Caplea Corporation *d/b/a* Caplea Studio Architects, 11700 Cleveland Avenue, NW, P.O. Box 1020, Uniontown, Ohio 44685. This project will include a “rebid” of bid packages #2 and #3. Bid Package #1 and #4 will not be part of the rebid process.

Bidders may submit requests for consideration of a proposed Substitution for a specified product, equipment or service to the Architect no later than ten (10) days prior to the bid opening. Additional products, equipment and services may be accepted as approved Substitutions only by written Addendum.

Prevailing wage rates do not apply to this project. Equal Employment Opportunity requirements apply to this project.

This project is subject to the State of Ohio’s Encouraging Diversity, Growth and Equity (“EDGE”) business development program. A bidder is required to submit with its bid information about the certified EDGE business enterprises participating on the project with the bidder or an affidavit for waiver for such requirements. The EDGE participation goal for the project is 5%.

The bidder may be subject to a pre-award affirmative action compliance review in accordance with Section 123:2-5-01 of the Ohio Administrative Code.

To the extent applicable, domestic steel use requirements as specified in Ohio Revised Code Section 153.011 apply to this project.

Bidders shall be enrolled in, and in good standing in a Drug-Free Safety Program (“DFSP”) approved by the Ohio Bureau of Worker’s Compensation prior to submitting a bid or enroll prior to commencing work and provide information upon request relative to their enrollment in such a program.

Bids will be received for the bid packages at the offices of the Treasurer of Schools located at 14277 South Main Street, Beloit, Ohio 44609. **Sealed bids will be received until July 14, 2015, at 1:00 p.m. when all bids will be opened and read aloud.**
