Important Notice from Mahoning County Schools Employee Insurance Consortium About Your Prescription Drug Coverage and Medicare

Please read this notice carefully and keep it where you can find it. This notice has information about your current prescription drug coverage with Mahoning County Schools Employee Insurance Consortium and the prescription drug coverage available since January 1, 2006 for people with Medicare. It also tells you where to find more information to help you make decisions about your prescription drug coverage.

- 1. Since January 1, 2006, Medicare prescription drug coverage has been available to everyone with Medicare.**
- 2. Express Scripts/Medical Mutual of Ohio has determined that the prescription drug coverage offered by the Mahoning County Schools Employee Insurance Consortium is, on average for all plan participants, expected to pay out as much as standard Medicare prescription drug coverage will pay.**
- 3. Read this notice carefully – it explains the options you have under Medicare prescription drug coverage, and can help you decide whether or not you want to enroll.**

You may have heard about Medicare's prescription drug coverage, and wondered how it would affect you. Express Scripts/Medical Mutual of Ohio has determined that your prescription drug coverage with *Mahoning County Schools Employee Insurance Consortium* is, on average for all plan participants, expected to pay out as much as the standard Medicare prescription drug coverage will pay.

Since January 1, 2006, prescription drug coverage has been available to everyone with Medicare through Medicare prescription drug plans. All Medicare prescription drug plans provide at least a standard level of coverage set by Medicare. Some plans might also offer more coverage for higher monthly premiums.

Because your existing coverage is on average at least as good as standard Medicare prescription drug coverage, you can keep this coverage and not pay extra if you later decide to enroll in Medicare coverage.

People with Medicare can enroll in a Medicare prescription drug plan from October 15, 2016 through December 7, 2016. However, because you have existing prescription drug coverage that, on average, is as good as Medicare coverage, you can choose to join a Medicare prescription drug plan later. Each subsequent year, you will again have the opportunity to enroll in a Medicare prescription drug plan between October 15th and December 7th.

If you drop your coverage with **Mahoning County Schools Employee Insurance Consortium** and enroll in a Medicare prescription drug plan, you may not be able to get this coverage back later. You should compare your current coverage, including which drugs are covered, with the coverage and cost of the plans offering Medicare prescription drug coverage in your area.

You should also know that if you drop or lose your current coverage with Mahoning County Schools Employee Insurance Consortium and don't enroll in Medicare prescription drug coverage after your current coverage ends, you may pay more to enroll in Medicare prescription drug coverage later. If after December 7, 2016 you go 63 days or longer without prescription drug coverage that's at least as good as Medicare's prescription drug coverage, your monthly premium will go up at least 1% per month for every month after December 7, 2016 that you did not have that coverage. For example, if you go nineteen months without coverage, your premium will always be at least 19% higher than what most other people pay. You'll have to pay this higher premium as long as you have Medicare coverage. In addition, you may have to wait until next October to enroll.

Remember: Keep this notice. If you enroll in one of the new plans approved by Medicare which offer prescription drug coverage after December 7, 2016, you may need to give a copy of this notice when you join to show that you are not required to pay a higher premium amount.
